Area II Procedure for RACES Net Controllers ONLY:

The MEMA Area II RACES Operators will use a form called A2S Reporting Form to compile and record the four (4) Area Sectors (2A, 2B, 2C, 2D) information. This information will be presented to the MEMA Area Director / Operations Officer or designee for action. Local Personnel do NOT need the AR2S Form.
